

NOTICE RE: April 1, 2020 MEETING OF CREDITORS

Due to the declaration of national emergency in response to the public health risk posed by the COVID-19 pandemic, the Office of the United States Trustee has provided the following Notice:

NOTICE REGARDING 341 MEETINGS OF CREDITORS

Effective immediately, all in-person chapter 7, 12, and 13 section 341 meetings scheduled through April 10, 2020, are hereby continued until a later date to be determined. Absent special circumstances, section 341 meetings may not proceed during this period except through telephonic or other alternative means not requiring personal appearance by debtors. Appropriate notice will be provided to parties in accordance with bankruptcy law and rules.

Meetings already noticed as telephonic meetings may proceed as scheduled.

Because the space for conducting the scheduled 341 meetings is not available, the Office of the United States Trustee has provided a telephone conference line to conduct the meeting of creditors. The provided dial in numbers and passcode are as follows:
