Meeting Instructions:

1. Use the above link and password to join the meeting. You can access the meeting with any computer, laptop, tablet, or smartphone with a camera, microphone and internet access. You will need to download and install a Zoom application if you do not have it already.
2. When you join the Zoom meeting you will be placed in a virtual waiting room. **When logging in, please use your real (FIRST & LAST) name so we know who is in the waiting room. If you are a creditor, include the Debtor's case number related to your claim.**
3. **When you join the meeting, please test your audio and video feeds.** We suggest that you join the meeting several minutes prior to the scheduled hearing to do this.
4. Multiple creditor meetings are conducted each half hour. You will not be brought into the room until your case is called.
5. Your identification and social security number must be verified during the hearing. Please have your photo identification such as a driver's license and social security documentation ready. For purposes of verifying your social security number we will need documentation that was prepared by a third party such as your original social security card or a W-2 form.
6. If you need language assistance, please let us know in advance of the hearing so we can make the necessary arrangements.
7. **Important: Creditors, please inform our office that you will be attending at least 24 hours in advance of the hearing. This will allow us to identify you and the relevant case when you enter the waiting room. In addition, please include the applicable case number when logging into the Zoom meeting.**
